### PREVIOUS ACTION

On February 19, 2019 under item 8.A the Board accepted a donation of a 2018 Ford Transit Wagon T-350 [VIN# 1FBZX2XM5KKA28637] from Grace Church for use by the Washoe County Human Services Agency's Crossroads Women's program to support the expansion of Crossroads on the Northern Nevada Adult Mental Health Services campus and Hope House [maintenance and service related costs are approximately

\$2,650.00 annually]; and approve the transfer of the vehicle to the Human Services Agency fleet managed by Equipment Services.

**BACKGROUND**

In 2017 Grace Church purchased, remodeled, furnished and gifted a home, Hope House, to the Human Services Agency as a means to provide safe, stable and supportive housing to women in our community, who are challenged with addiction or mental health issues. Hope House also provides a location for children who have been separated from their mothers due to addiction, homelessness or mental health to safely reunify. Grace Church continued to support Hope House and women in Washoe County through a second financial donation of \$225,000 to re-habilitate three cottages on the Northern Nevada Adult Mental Health Services (NNAMHS) Campus, The Cottages, allowing HSA to expand the Crossroads women’s program. Grace Church continues to support women and families in Washoe County through the purchase of two multi passenger vans to assist with transportation of the residents. The first van was accepted by the Board on February 19, 2019 and will be a valuable asset to insure the women and children served by Crossroads have consistent and reliable transportation available 24 hours a day to services, school, work and emergencies. Vans will be driven by Washoe County employees, contractors, and volunteers who have successfully satisfied Washoe County requirements for Defensive Driving and background screening.

**FISCAL IMPACT**

Should the Board accept the donation of the 2018 Ford Transit Wagon, there will be no additional fiscal impact to the adopted FY19 budget. All maintenance and service related costs associated with this vehicle estimated at \$2,650.00 annually, will be absorbed within the Human Services Agency Indigent Fund (221) in internal order 60515 (Crossroads Hope House) as follows:
