### **SUMMARY**

This item requests the Board to approve resolutions and transfers/disbursements allocating district funds in the [total amount of \$5,000] for Commission District 2 to support the Reading Room project at the Second Judicial District Court, STEAM initiatives at the South Valleys Library, and the Washoe County Library System's Give the Gift of Reading: 2018 Children's Literacy Fundraising Campaign.

Washoe County Strategic Objective supported by this item: Safe, Secure and Healthy Communities.

### **PREVIOUS ACTION**

No previous action taken during the Fiscal Year 2018-2019.

### **BACKGROUND**

Modification of guidelines and adoption of resolution for County Commission District Special Funding on February 10, 2015 created Commission District Special Funds for each

Commission District. On May 22, 2018 the Board of County Commissioners approved the 18-19 Fiscal year budget with special district funds allocated per Commission District in the amount of \$20,000. The monies appropriated are to support needs for all Washoe County residents.

Funds appropriated through the Commission District Special Funds must provide substantial benefit to the inhabitants of the County. The recipient must be a non-profit organization, created for religious, charitable or educational purposes, or a government entity. Funds shall not provide any personal or private benefit for the Commissioners, direction or indirectly benefit any campaign efforts by a commission, violate Ethics in Government law, or be used to purchase tickets to special events.

Commissioner Lucey has elected to support the following organization in fiscal year 2018-19:

**District 2:**

Second Judicial District Court [\$2,000]. The Second Judicial District Court developed the Reading Room project with the intent of providing a welcoming space to reduce trauma for children and families attending Court, and to provide a book to each child who comes to Court. The children and families who attend Court are parties to proceedings involving child abuse and neglect, child support and custody, child delinquency, divorce, protective orders, and minor guardianship. Children and families also access the Second Judicial District Court through the Self Help Center, Law Library, Temporary Protection Office, and Family Peace Center. This grant will support the Reading Room project.

Friends of Washoe County Library [\$1,500]. This grant will support STEAM (Science, Technology, Engineering, Arts, Math) related programs and services for kids, teens, and adults at the South Valleys Library.

Friends of Washoe County Library [\$1,500]. This grant will support the Washoe County Library System’s Give the Gift of Reading: 2018 Children’s Literacy Fundraising Campaign. Research shows that the most reliable predictor of school success is being read to during early childhood. Reading to children from an early age can help prepare children to enter kindergarten with the skills necessary for success. Most importantly, sharing books with children promotes a lifelong love of books and reading. Nevada is ranked among the lowest graduation rates in the nation. This program will help support the Washoe County School District’s efforts in increasing a student’s success rate at an early age.

**FISCAL IMPACT**

Funds have been included in the FY 2018-2019 approved budget under Commission District Constituent cost centers: District 2 – 100102/710400. This action requests approval and distribution of a [total of \$5,000] as outlined.
