

RESOLUTION**A RESOLUTION TO COLLECT CERTAIN
DELINQUENT UTILITY CHARGES ON THE TAX ROLL**

WHEREAS, Washoe County owns and operates reclaimed water, recharge water (in Golden Valley), wastewater, and Spanish Springs flood control utilities (“Utilities”) through its Community Services Department (“Department”); and

WHEREAS, the Department charges, and relies on, customer rates to provide services associated with the Utilities that are desired by the public; and

WHEREAS, as of March 31, 2022, various utility accounts were delinquent; and

WHEREAS, as of May 20, 2022, Three Hundred and Eighty-Five (385) Assessor Parcel Numbers (APNs), that were delinquent as of March 31, 2022, continued to be delinquent; and

WHEREAS, NRS 244.157, NRS 318.201, and Washoe County Ordinances authorize delinquent utility charges to be collected on the tax roll annually; and

WHEREAS, delinquent utility customers were provided notice that delinquencies as of March 31, 2022, not paid by May 20, 2022, would be attached to the tax roll; and

WHEREAS, customers still delinquent as of May 20, 2022 were provided notice of the public hearing to be held on June 21, 2022, at 10:00 a.m.; and

WHEREAS, a Notice of Public Hearing was published in the Reno Gazette Journal once a week for two weeks prior to the date set for the hearing.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE IN THE STATE OF NEVADA:

Section I. The following APNs that had utility balances delinquent as of March 31, 2022, and continued to be delinquent as of May 20, 2022, shall be attached to the tax roll by the Treasurer’s Office and collected in the same manner, by the same persons, and at the same time as, together with and not separately from, the county’s general taxes:
