### SUMMARY

This item requests the Board to approve a resolution and transfer/disburse district funds in the [total amount of \$25,000] for Commission District 2 and Commission District 4 to support the safe, secure, and healthy communities' initiative.

### PREVIOUS ACTION

Commission District 2:

No previous action taken during the Fiscal Year 2017-2018.

Commission District 4:

September 12, 2017 – Board of County Commissioners approved allocating district 4 funds in the amount of \$1,000 to The First Tee of Northern Nevada to help support the National School Program at one elementary school in Washoe County.

July 11, 2017 – Board of County Commissioners approved allocating district 4 funds in the amount of \$1,000 to The Nevada Discovery Museum to support their vision to be the community's center that inspires curiosity, creativity and the joy of lifelong learning.

**BACKGROUND**

Modification of guidelines and adoption of resolution for County Commission District Special Funding on February 10, 2015 created Commission District Special Funds for each Commission District. On May 23, 2017 the Board of County Commissioners approved the 17-18 Fiscal year budget with special district funds allocated per Commission District in the amount of \$20,000. The monies appropriated are to support needs for all Washoe County residents.

Funds appropriated through the Commission District Special Funds must provide substantial benefit to the inhabitants of the County. The recipient must be a non-profit organization, created for religious, charitable or educational purposes, or a government entity. Funds shall not provide any personal or private benefit for the Commissioners, directly or indirectly benefit any campaign efforts by a commissioner, violate Ethics in Government law, or be used to purchase tickets to special events.

Commissioner Lucey and Commissioner Hartung have elected to support the following organizations in fiscal year 2017-18:

Community Foundation of Western Nevada - Youth Engaged in Service (YES) Fund [\$25,000], (\$10,000 from District 2 and \$15,000 from District 4) - This grant will establish this fund and support youth planned and youth lead community service projects that improve the quality of life in Washoe County.
