SUMMARY

It is requested that the Board of County Commissioners (BCC) accept a donation from the City of Sparks of [\$5,000.00] for a regional Flood Response Action Plan (FRAP) and authorize Comptroller to make appropriate budget amendments.

Washoe County Strategic Objective supported by this item: Safe, Secure and Healthy Communities

PREVIOUS ACTION

On April 10, 2018 the Board of County Commissioner approved an ICA with Truckee River Flood Management Authority to contribute \$25,000 towards the regional FRAP. On April 24, 2018 the Board of County Commissioner approved an ICA with the City of Reno to contribute \$10,000 towards the regional FRAP.

BACKGROUND

Washoe County, the City of Reno, the City of Sparks, TRFMA, Reno-Sparks Indian Colony, and the Pyramid Lake Paiute Tribe have developed and maintain a Flood Response Action Plan. The FRAP serves as the overarching operational document to guide the regional partners through the response to and recovery from flood incidents.

Because of recent flooding events it was necessary to update the FRAP, and Washoe County engaged the services of Ecology and Environment, Inc. to conduct that work. The City of Sparks is making a donation to contribute to efforts to update the FRAP as one of the Washoe County Regional Partners.
