SUMMARY

Washoe County Regional Animal Services has been the recipient of cash donations totaling \$7,319.88 donated for the use of the humane care and treatment of sick and/or injured, stray, abandoned, or at risk animals received.

BACKGROUND

For the period of July 1, 2017 to September 30, 2017, Washoe County Regional Animal Services was the recipient of cash donations totaling \$7,319.88. (Reference attached list).

This agenda item would have been heard at the November 21, 2017 Board of County Commissioner's meeting, but that meeting was cancelled.

Donations are generally used to encourage responsible pet ownership, seek treatment of sick or injured animals, or at risk animals, and to promote humane treatment of animals.
