Letter of Intent is stating the State of Nevada, Division of Emergency Management (NDEM) is awarding [\$225,555.20, \$225,555.20 County match required] for FFY 2022 including funds to be used for travel; retroactive from October 1, 2021 through September 30, 2023; If approved authorize the County Manager or his designee to sign the grant award documents when received; and direct the Comptroller's Office to reimburse the General Fund through transfer for the expense of [\$56,807.03] salary and benefits for the Emergency Management Administrator incurred in FY 22 and to make the necessary budget amendments. # **SUMMARY**

This item recommends that the Washoe County Board of County Commissioners (the Board) approve Letter of Intent for the FFY 2022 EMPG. Letter of Intent stating the NDEM is awarding [\$225,555.20, \$225,555.20 County match required] for FFY 2022 including funds to be used for travel; retroactive from October 1, 2021 through September 30, 2023; If approved authorize the County Manager or his designee to sign the grant award documents when received; and direct the Comptroller's Office to reimburse the General Fund through transfer for the expense of [\$56,807.03] salary and benefits for the Emergency Management Administrator incurred in FY 22 and to make the necessary budget amendments.

The Board annually accepts the Emergency Management Performance Grant (EMPG) to fund a portion of the County's Emergency Management program. The State of Nevada, Division of Emergency Management has provided this grant award to Washoe County for more than 19 years. The EMPG program provides funding to assist local governments to sustain and enhance all-hazards emergency management activities. This grant is retroactive due to the delay of the US Department of Homeland Security releasing the funds to the Nevada Division of Emergency Management.

Washoe County Strategic Objective supported by this item: Support a thriving community.

## PREVIOUS ACTION

**August 17, 2021** - The Board approved the letter of intent from NDEM to award \$253,502.00 for EMPG and directed the comptroller to make the necessary budget amendments.

**August 18, 2020** - The Board approved the letter of intent from NDEM to award \$170,877.00 for EMPG and directed the comptroller to make the necessary budget amendments.

**June 25, 2019** - The Board approved the letter of intent from NDEM to award \$170,877.00 for EMPG and directed the comptroller to make the necessary budget amendments.

**June 19, 2018** – The Board of County Commissioners accepted a Letter of Intent for an 2018 EMPG from the State of Nevada, Department of Emergency Management for \$170,877.00 [with a County match of \$170,877.00]; and directed the Comptroller's Office to make the appropriate budget amendments.

**June 27, 2017** – The Board of County Commissioners accepted a Letter of Intent for an 2017 EMPG from the State of Nevada, Department of Emergency Management for \$170,877.00 [with a County match of \$170,877.00]; and directed the Comptroller's Office to make the appropriate budget amendments.

**June 28, 2016** – The Board of County Commissioners accepted a Letter of Intent for an 2016 EMPG from the State of Nevada, Department of Emergency Management for \$170,877.00 [with a County match of \$170,877.00]; and directed the Comptroller's Office to make the appropriate budget amendments.

The Board has approved this grant for the past 19 years.

#### BACKGROUND

This grant provides partial funding for the Washoe County Emergency Management Administrator position, consulting services for avalanche and weather advisory services, plan updates, training, supplies, and operating expenses for the Regional Emergency Operations Center.

This grant requires a 100% match.

#### FISCAL IMPACT

This grant requires a 100% match. The County will provide [\$102,335.61] in Emergency Management Performance Grant Match Cost Center (155110) and [\$123,219.59] from WCSO Search and Rescue Cost Center (150680), total [\$225,555.20]. No indirect costs are being recovered.

Should the board accept this grant award and approve these amendments, the adopted budget will be increased by [\$150,715.56] in revenues. Budget authority for personnel expenses is projected and accounted for in the FY 23 adopted budget. The below budget amendment is for increased authority in Services and Supplies in the amount of [\$93,908.53], as well as a [\$56,807.03] transfer to reimburse the General Fund for expenses incurred in FY 22.

The FFY 2022 EMPG award totals [\$225,555.20] for the period of October 1, 2021, through September 30, 2023, with the personnel category performance period retroactive from October 1, 2021, through September 30, 2022. In FY 22, there were [\$56,807.03] in actual expenditures and budget expenditure authority of [\$168,748.17] has been accounted for in the FY 23 budget within Internal Order FY22 EMPG (IO 11896).
