### SUMMARY

The Washoe County Sheriff's Office Citizen Corps Program has received a donation in the amount of \$1,500.00 for their volunteer efforts at the Reno Air Races, a community event held September 9 through 15, 2019. This donation will go to support the Citizen Corps Programs (CCP), whose volunteer teams include the Community Emergency Response Team (CERT), Citizen's Homeland Security Council (CHSC) / Terrorism Liaison Officer Volunteer (TLOV) program, and Rail Auxiliary Team.

These funds are intended to be used to support the CCP teams, including but not limited to the purchase or repair of equipment, supplies, food and beverage to be used in emergency response, training, drills, support events or rehab during disasters, in support the Citizen Corps Programs.
