### **PREVIOUS ACTION**

On December 18, 2018, the Board approved item #7.A, donated murals valued at \$3,000.00 from artist Kandyce Ray to the Second Judicial District Court.

On April 26, 2022, the Board approved item #7.D.1, donations at an estimated value of \$2,820.00 from the Reno Rodeo Foundation and Tru Vista to the Second Judicial District Court.

### **BACKGROUND**

The Second Judicial District Court developed the Reading Room project with the intent of providing a friendlier and warmer space for children and families attending court and to provide a book to each child who comes to court. The Reno Rodeo Foundation provides ongoing donations of books to ensure each child who comes to court can leave with a book.
