SUBJECT: Recommendation to accept the Epidemiology & Laboratory Capacity (ELC) Subaward # SG25588, [amount not to exceed \$279,246.00, no County match required] as administered through the State of Nevada, Department of Health and Human Services, Division of Public and Behavioral Health, to purchase COVID-19 test kits, personal protective equipment, and FACE Plus Matching Recognition System, for the retroactive grant period of May 1, 2022 through April 30, 2023 and if approved, direct Comptroller's Office to make the necessary budget amendments. SUMMARY

This funding received from the State of Nevada, Department of Health and Human Services, Division of Public and Behavioral Health has provided funds through the Epidemiology & Laboratory Capacity (ELC) program to purchase COVID-19 test kits, personal protective equipment, and FACE Plus Matching Recognition System.

BACKGROUND

NRS 211, Local Facilities for Detention, mandates the Sheriff to have charge and control over all prisoners committed to his care and provide for administration of medical care while in custody to include the treatment for any infectious, contagious, or communicable diseases while in custody (NRS211.140(4)(b)).

The dynamics of the inmate population has changed where there are more mentally ill inmates causing an increase of exposure to bodily fluids. By having COVID-19 test kits available as well as personal protective equipment (PPE), we can continue to improve the

healthy environment by reducing the possibility of inmates contracting contagious disease through bloodborne / airborne pathogens. It will also aid in reducing the need to transport and guard inmates, normally requiring overtime, to and in the hospital, while being treated for infectious diseases.

A Sole Source document was submitted to purchase the DataWorks FACE Plus Matching System due to the fact the equipment MUST be compatible with existing equipment. The Washoe County Detention Facility currently has established existing equipment with DataWorks and the addition of the FACE Plus server and software helps mitigate the exposure and spread of COVID-19 and other infectious and communicable diseases by minimizing contact with inmates.

Reason for retroactive submittal: Item was submitted to the first available BCC meeting once all paperwork was received and processed.
