BACKGROUND

For the period of April 1, 2018 to June 30, 2018, Washoe County Regional Animal Services was the recipient of cash donations totaling \$9,267.17. (Reference attached list).

Donations are generally used to encourage responsible pet ownership, seek treatment of sick or injured animals, or at risk animals, and to promote humane treatment of animals.
