### SUMMARY

Approve the donation of a damaged tow trailer from Williams Tank Lines to the Regional Public Safety Training Center (RPSTC) to be used as a static training prop at the RPSTC.

**Washoe County Strategic Objective supported by this item:** Safe, Secure and Healthy Communities

### PREVIOUS ACTION

The Board approved a similar donation of buses to be used as static training props on February 20, 2018.

### BACKGROUND

Williams Tank Lines is one of the largest for hire bulk carriers in California. The company operates over 100 units out of 9 different locations in California and 2 locations in Nevada.

After a severe traffic accident, Williams Tank Lines salvaged a 20 foot tow trailer that was damaged beyond serviceable repair. The tow trailer is located at the Reno-Sparks Terminal. Williams Tank Lines has offered this damaged trailer to the RPSTC to be used as a static training prop, which would be located at the Skills Training Area of the RPSTC.

The static tow trailer will be used by partner agencies, as well as other entities, to simulate tractor trailer accidents, Haz-Mat incidents, and other First Responder training.
