MHIFREAS, the Novada State Loglelature did approve, in June of 1989, en manclemant ta Chaptex 278 of R.R.S. entabliphing a regional planaing conciacion and magional planning governing boazd for the juxiedictions of Reno, Sparks and wimoo county; requixing tha threa local governmante to cooperate in the timely development and adoption of a comprahenaive regional plan; and fuxther reguiring thi local governmente ta ohare propoxtlonaliy in the coste of etaffing and carxylng out the ragiomal planning functionm inciuding legal eorvicea neoded by the regional planing commimadon or the geverning boaxd: and

WHBREAS, the Nevada state Lagislacure further requixif the regional plamalng governing board aach yaar to adopt an annual budget auffieient to enable it to carcy out lter mandited functione and to tranemit thia annual budget to each mamber'a local govarnmont as a. recommendation for funding; and

Whersas, the city of Reno, the clty of sparke and wahoo county are the partielpating local government menbers of the Truckee Meadown Regional planning Agency; and

WHEREAS, each of thete membere is a "public agency" within the meaning of NRS 277 . 100 and is capable of entering into an Interlocal Agreement expeuted in accoxdance with the Interlocal Cooperation Act (NRS'277.080 to 277.180, inciusive)s

NOW, THEREEORE, IT IS HEREBY RGREED by each of the parties herato as followes
A. The partiae to thle Interlocal Agreement hereby commit to provide funding during the fiecal yeax beginning July 1,1990 and ending June 30,1991 to aupport the annual regional planning activities of the regional planning governing board, ite planning commiseion and lte staft, in tha following proportional amounter:

| City of Reno | $\$ 200,800.00$ | $(40$ percent) |

| City of Sparks | $\$ 250,600.00$ | $(30$ percent |
| County of Wamhoe | $\$ 250,600.00$ | $(30$ percent) |

B. Tha partiea hereto further commit to provide funding in tha ame propoxtlonal amounte in future fiscal yeare purbuant to budgats adopted by the regional planning governing board for the support of regional planning activitien.
C. The city of Sparke Finance Director is hexeby denignatad as the Depositary Manager for funde provided by the parties to this agreement. The Deponitory Manager mhall provide for proper accounting for all revenues and expenditures apmociatad with the regional planning agency activites; ia authoxized to apply reasonable common eervice charges to racover the costs of providing accounting and adminiatrative sarvices; and hall provide intereat revenues for funde hald on deposit by the city of sparks.
D. The parties to this agreement hereby direct their finance directors, or treasurer, to provide the regional planning funds specified in this agreement on a quarterly basis, with quarterly ingtallmentis due on July 15 , october 15, January 15 , and April 15 of each fiscal year.
E. Funde not expended in a flecal year may be carried forward into the succeeding flscal year budget and shall ba fhown as fund balance therein.
F. Cobts for all legal services needed by the regional planning commiestion or the governing board ahall be shared proportionaliy as ahown above. An amount for legal services ehail be identified in each fiscal year budget.

G. The Executive Director of the Truckee Meadown Ragional planning Agency la hereby dealgnated an the Administrator for the revenues and expanditurea provided purauant to thin agrmemant: The Adminiatrator shall be responmibla for managing and coordinating budgated revenues and expenditures throughout the fiacal yeing for. approving all claime for payment; and for providing menber aganciea with an annual xaport on the etatua of the regional planning agency accounts and the praxpome: toward which axpenditures have been made.
G. The Adminimtrator, in cooperation with the Depository Manager, shall arranga for an annual independant audit of the regional planning funds and accounte and shall present the reaulta of auch audlt to the parties algnacory to thle agreement.
I. The original copy of thif agreement ad aigned by all partiea hereto shall be forwarded to the Navada Attorney General in accordance with NRS 277.140 , and upon approval by the Nevada Attorney Ceneral thia agraament shall be filed in the mannac required by acatute and shall have the force and effect of law. The Exacutive Director is diracted to file a copy of thia Agrement in the office of the wamoe County Recorder and in the office of the Navada Sacretary of state.
