SUMMARY

The Library is requesting Board's approval of grant funds from the State of Nevada, Department of Conservation and Natural Resources Commission For Cultural Centers and Historic Preservation in the amount of [\$10,632; no County match required] for a grant term beginning July 1, 2019 through May 1, 2020, for Downtown Reno Library Renovations; Direct the Comptroller's Office to make the necessary budget amendments; and authorize the Library Director to sign the grant award documents.

BACKGROUND

The Washoe County Library initially applied for a \$75,000 State Historic Preservation Office grant to help defray costs to renovate the Downtown Reno Library, restore original functions, and expand the children's section of the library. The State Historic Preservation Office awarded us \$10,632. in grant funding to support the public art and restoration of historic features of the building.

GRANT AWARD SUMMARY

Project/Program Name: Downtown Reno Renovations.

Scope of the Project: Grant funding is awarded via a competitive process through the State of Nevada. These funds will be used to provide and enhance the outdoor area of the Downtown Reno Library. The planning design includes a protective decorative cap or artistic fence that would sit on top of the planter wall around the Downtown Reno Library. The cap will allow the exterior wall to be preserved while providing a small decorative cap highlighting the historic library. The design will replicate a shelf of books and will also say LIBRARY in block letters.

Benefit to Washoe County Residents: Public Art is a major component of the City of Reno Downtown Culture Master Plan. The Downtown Reno Library sits right in between Downtown and Mid-Town Reno making it the linchpin to keeping the community connected. It is not only directly connected to other cultural resources, but also has historical connections to the City of Reno. As one walks around the area, one can see large sculptures and cultural resources throughout the Downtown area. We are adjacent to the Terry Lee Wells Discover Center and the Nevada Museum of Art. The Downtown Reno Library is a key piece of the cultural community both in the services it provides and the buildings it inhabits. The Washoe County Library System intends to use the grant funds to beautify the surrounding area to increase visibility, but also to make this great cultural resource stand out to better serve the population. Sculptures and other public art will surround the building to make the library more visible and consistent with the Downtown Reno look. The Downtown Reno Library holds a historical archive that's an asset to the community.
