FISCAL IMPACT

Donations for the various Regional Parks and Open Space facilities, programs and events have been deposited to IN20020, Parks Donations (\$13,355.90) and IN20021, Hawkins Amphitheater Donations (\$112.17) in the Other Restricted Fund 270 -2710.

There is no above-base maintenance costs associated with any of these donations. The donations enable Regional Parks and Open Space to offer programming or assist in repairing, replacing or maintaining facilities and items that are not supported by appropriations elsewhere, and to support volunteer efforts with no impact to the general fund.
