Explanation: Overassessment due to factual error-existence. The residence on this parcel was valued at 100% complete for the 2021-2022 roll year in error. Based on conversation with the owner/builder and the inspection record from the City of Sparks, it was determined that the residence was actually 70% complete and the Certificate of Occupancy was not issued until 11-24-2021. Also, based on an interior inspection on November 30, 2021 the quality class needs to be corrected to 2.5. This roll change request would correct the 2021-2022 tax roll to reflect the corrected quality class and the estimated percent complete of the improvements as July 1, 2021.
