SUBJECT: Recommendation to approve the Sheriff's Security Agreement between the Hyatt Regency – Lake Tahoe and the Washoe County Sheriff's Office to provide uniformed Deputy Sheriffs for security [no charge to the County] during requested Hyatt Events, retroactively from May 1, 2019 through January 1, 2022 to be held at the Hyatt Regency – Lake Tahoe in Incline Village, Washoe County. (Commission District One)

SUMMARY:

The Hyatt requested the Washoe County Sheriff's Office provide uniformed Deputy Sheriffs to aid with security at specific Hyatt Events occurring on Hyatt property in Incline Village, Washoe County. The agreement provides for reimbursement to the County for the cost of providing the uniformed Deputy Sheriffs and vehicles.

Washoe County Strategic Objective supported by this item: Economic Impacts and Unified Team/Employee Engagement

PREVIOUS ACTION

On February 23, 2016, the Board approved similar Security Agreements with the Hyatt.

On July 14, 2017, the Board approved similar Security Agreements with the Hyatt.

BACKGROUND

The Washoe County Sheriff's Office was approached by the Hyatt to provide uniformed Deputies to aid with security during various events to be held in Incline Village, Washoe County, NV. Though these events are not new to the Hyatt or Incline Village, the popularity has increased along with the residential and tourist crowds. The agreement being submitted for

approval is for the 2019-2022 calendar years, and was submitted to the first available BCC meeting upon receipt of signed contract.

FISCAL IMPACT

There will be no fiscal impact to Washoe County General Fund. All personnel costs including benefits and the use of WCSO equipment will be paid by the Hyatt. Reimbursement received will be deposited to account 150200-485129 (Office of the Sheriff – Salary Reimbursement). Reimbursement will vary according to staffing and equipment assigned to each event.

RECOMMENDATION

It is recommended that the Board of County Commissioners approve the Sheriff's Security Agreement between the Hyatt Regency – Lake Tahoe and the Washoe County Sheriff's Office to provide uniformed Deputy Sheriffs for security [no charge to the County] during requested Hyatt Events, retroactively from May 1, 2019 through January 1, 2022 to be held at the Hyatt Regency – Lake Tahoe in Incline Village, Washoe County.
