PREVIOUS ACTION

Juvenile Services has had agreements the past several years with specific departments within the University of Nevada, Reno to provide students with educational experiences. The University of Nevada, Reno, however, has recently changed its internship procedures and is now using a new form in order to streamline their processes. This new Organization Agreement will continue to enhance the partnership between the two entities.

The purpose of the agreement is to continue the current relationship with the University of Nevada, Reno in order to provide students opportunities to earn school credit while participating in educational experiences that will prepare them for careers in their respective professional fields.
