**SUBJECT:** Recommendation to authorize MWH Constructors and KG Walters

Construction (MWH&KGW), a joint venture, as the Construction-Manager-At-Risk (CMAR) and approve a Guaranteed Maximum Price Agreement (GMP) 3C for the Early Equipment Procurement Package associated with the South Truckee Meadows Water Reclamation Facility 2020 Expansion Project, in the amount of [\$9,792,598.00]. (Commission

District 2.)

#### **SUMMARY**

The Community Services Department is requesting authorization to award Guaranteed Maximum Price (GMP) 3C (GMP 3C) to the Construction Manager at Risk (CMAR), MWH Constructors and KG Walters Construction, a joint venture, (MWH&KGW), for the early equipment procurement associated with the South Truckee Meadows Water Reclamation Facility (STMWRF) 2020 Expansion Project (Project).

Due to long lead times associated with manufacturing this equipment staff determined it is critical to the overall project schedule to procure the equipment under a separate GMP while finalizing design of STMWRF 2020 Expansion Project (GMP 4). The CMAR's scope, as part of GMP #3C, is to supply the mixers (total 24), turbo blowers (total 5), rotary blowers (total 4), grit basin, pumps (total 4), diffusers (total 4), generator and miscellaneous electrical equipment all of which will be installed during construction phase of above stated GMP 4.

Washoe County and MWH&KGW have negotiated a Guaranteed Maximum Price (GMP) for the equipment in the amount of \$9,792,598.00, which includes the total competitive bid price of the equipment in an amount \$6,880,489.00, CMAR overhead and profit in the amount of \$894,464.00 and bonds and insurance in the amount of \$154,329.00. A total of \$1,863,316.00 is included in the GMP for Owner allowance/contingencies in the event there are additional scope items that need to be added to the project or changes to specifications after the GMP has been approved.

Future phases of the STMWRF expansion will include improvements to influent pumping, headworks, digesters, dewatering process, electrical services, all associated with capacity expansion.

## **PREVIOUS ACTION**

On November 16, 2021, the Board of County Commissioners (Board) approved the Owner-CMAR construction agreement, to construct Bioreactors 3 and 4 - Walls and Facility Upgrades under a Guaranteed Maximum Price agreement, GMP 3B, a separate guaranteed maximum price agreement for the South Truckee Meadows Water Reclamation Facility 2020 Expansion Project in the amount of \$9,641,068.00; and approved a separate project contingency/owner allowance fund in the amount of \$3,205,400.00.

On August 24, 2021, the Board approved the Owner-CMAR construction agreement, to construct Bioreactors 3 and 4 Excavation and Base Slab Early Work Package under a Guaranteed Maximum Price agreement, GMP 3A, a separate guaranteed maximum price agreement for the South Truckee Meadows Water Reclamation Facility 2020 Expansion Project in the amount of \$5,118,278.74.

On May 18, 2021, the Board approved the Capital Improvements Plan for Fiscal Years 2022-2026.

On July 14, 2020, the Board approved the Capital Improvements Plan for Fiscal Years 2021-2025.

On November 10, 2020, the Board approved the Owner-CMAR Agreement for the CMAR to construct Influent Pump and Screen Replacement Project under a Guaranteed Maximum Price agreement, GMP 2, a separate guaranteed maximum price agreement for the South Truckee Meadows Water Reclamation Facility 2020 Expansion Project in the amount of \$2,749,323.

On August 31, 2020, the Board approved the Owner-CMAR Agreement for the CMAR to procure and supply Enclosed Screw Pumps and Perforated Plate Escalator Screen under a Guaranteed Maximum Price agreement, GMP 2A, in support of the South Truckee Meadows Water Reclamation Facility 2020 Expansion Project in the amount of \$1,236,283.

On May 26, 2020, The Board approved an Agreement for Professional Consulting Services for Construction Management Services between Washoe County and HDR Engineering, Inc., in support of the South Truckee Meadows Water Reclamation Facility 2020 Expansion Project in the amount of \$5,305,577.27.

On April 21, 2020, the Board adopted an ordinance authorizing the issuance by Washoe County, Nevada of its General Obligation (Limited Tax) Sewer Bond additionally Secured by Pledged Revenues) Series 2020 in the maximum principal amount of [\$27,000,000] for the purpose of financing sewerage projects for the County; providing the form, terms and conditions thereof and covenants relating to the payment of said bond; and providing for its adoption as if an emergency exists; and providing other matters relating thereto.

On January 12, 2020, the Board approved an Agreement between Washoe County and MWH Constructors/KG Walters Construction for CMAR Pre-Construction Services for the South Truckee Meadows Water Reclamation 2020 Facility Expansion Project within the South Truckee Meadows Water Reclamation Facility service territory in the amount of \$631,280.

On June 11, 2019, the Board approved an Agreement for Professional Consulting Services for the Washoe County South Truckee Meadows Wastewater 2020 Expansion

Project Owner's Representative Services between Washoe County and Jacobs Engineering Group for Phase I design services and facility plan updates in the amount of \$1,530,922.

On May 21, 2019, the Board approved the Capital Improvements Plan for Fiscal Years 2020-2024.

On March 26, 2019, the Board held a public hearing on the County's intent to issue General Obligation (Limited Tax) Sewer Bonds (Additionally Secured by Pledged Revenues).

On February 26, 2019, the Board adopted a resolution of intent to issue general obligation sewer bonds in the maximum principal amount of \$50,000,000 for construction of needed sewer utility projects as identified in the South Truckee Meadows Water Reclamation Facility Plan.

On February 15, 2019, and as required per NRS 350.14, the Washoe County Debt Management Commission approved a resolution concerning the submission to the Washoe County Debt Management Commission of a proposal to issue Washoe County, Nevada General Obligation Sewer Bonds (additionally secured by pledged revenues) in the maximum principal amount of \$50,000,000; and approved certain details in connection therewith.

On February 12, 2019, the Board approved an Agreement for Professional Consulting Services for the Washoe County South Truckee Meadows Wastewater 2020 Expansion Project Owner's Representative Services between Washoe County and HDR Engineering in the amount of \$375,244.

On January 15, 2019, the Board adopted a resolution directing the Clerk to notify the Washoe County Debt Management Commission of the County's proposal to issue its Washoe County, Nevada General Obligation (Limited Tax) Sewer Bonds (additionally secured by pledged revenues) in the maximum principal amount of \$50,000,000 for sewer projects: providing certain details in connection therewith; and providing the effective date hereof.

On December 11, 2018, the Board directed staff to apply for a \$50 million loan from the State of Nevada Clean Water State Revolving Fund (SRF) Loan Program.

On October 24, 2017, the Board approved an Agreement for Consulting Engineering Services between Washoe County and Carollo Engineers, Inc. to provide engineering services for sanitary sewer flow and water quality analysis in the existing collection system within the South Truckee Meadows Water Reclamation Facility and Spanish Springs service areas.

On March 10, 2015, the Board approved an agreement for consulting engineering services with Carollo Engineers Inc., in the amount of \$340,438, to provide planning and engineering services for the South Truckee Meadows Water Reclamation Facility 2015 Facility Plan Update Project.

On February 13, 2007, the Board awarded an agreement for consulting engineering services with CH2M Hill Inc. to provide facility planning and preliminary engineering services for the South Truckee Meadows Water Reclamation facility.

On August 20, 2002, the Board adopted the South Truckee Meadows Water and Wastewater Facility Plan.

## **BACKGROUND**

Washoe County owns and operates the STMWRF which provides sewer treatment to approximately 22,000 homes and businesses within southern Washoe County, including significant portions of the City of Reno. The facility was commissioned in 1990 and expanded in 2003. STMWRF is presently configured to treat up to 4.1 million gallons of sewage per day. Wastewater influent flows to STMWRF are presently 3.5 million gallons per day and increasing approximately 3-percent annually.

Since STMWRF is nearing its permitting capacity, the State of Nevada Division of Environmental Protection requires that Washoe County update facility planning to ensure the next phase of sewer capacity is thoughtfully planned and ready when needed. Major infrastructure improvements at STMWRF can take 3-5 years to plan and construct. At this point in the project, it is estimated the cost of the expansion of STMWRF to respond to the needs to treat and manage additional flows, is between \$50 million and \$70 million. The actual cost will be determined through the facility needs, design and bidding process and this estimate should be considered only an estimate and is in alignment with current regional cost estimates and industry standards. All agreements for design and construction will be brought to the Board for review and approval as required. Funding for this project comes from connection fees paid by new development, collected under the terms of Washoe County utility ordinances.

The Washoe County Utility has proactively planned for the required expansion of the STMWRF and Huffaker Hills Effluent Reservoir Lining Project and has sought and received approval for up to \$50 million in loan funding from the State of Nevada Clean Water, State Revolving Fund. The Board adopted an ordinance authorizing the issuance of the first \$27M in support of the project in January 2021 and an additional ordinance in December 2021 authorizing the second issuance of \$23M 2022 Sewer Bonds.

# **FISCAL IMPACT**

Sufficient budget authority in FY22 exists for the GMP 3C construction agreement as well as additional contingency/owner allowance in the Utilities Fund (566), STMWRF 2020 Expansion (WR860109), Construction Contracts (781080). Revenues in support of the expansion project are provided from sewer connection fees.

It is recommended the Board of County Commissioners authorize MWH Constructors and KG Walters Construction (MWH&KGW), a joint venture, as the Construction-Manager-At-Risk (CMAR) and approve Guaranteed Maximum Price Agreement (GMP) 3C for the Early Equipment Procurement Package associated with the South Truckee Meadows Water Reclamation Facility 2020 Expansion Project, in the amount of [\$9,792,598.00].
