SUMMARY

BACKGROUND

The Achievement in Excellence in Procurement Award Program is designed to measure and recognize organizational excellence in procurement based upon innovation, professionalism, e-procurement, productivity, and leadership attributes of the agency's purchasing function. Washoe County is one of only 6 agencies in Nevada and one of only 45 counties in the United States and Canada to receive the award.

Procurement activities upon which this award is based are the chief responsibilities of the Purchasing Division of the Washoe County Comptroller's Department and could not have been accomplished without the professional and dedicated services of the Purchasing staff of Pamela Mann, Joan Maddalena and Kris Hansen and Barbara Isbell.

Purchasing and contracting at Washoe County are cooperative efforts involving every department and the Board of County Commissioners, whose continued support and
