**SUBJECT:** Recommendation to award a bid and approve the Agreement to the lowest responsive, responsible bidder for the Washoe County Parks Flood Damage Repair Project, [staff recommends Impact Construction, in the amount of \$166,286]. (All Commission Districts.)

### SUMMARY

The Washoe County Parks Flood Damage Repair project consists of repair and reconstruction in eleven Washoe County owned parks and open space parcels including: Anderson Park, re-grading the existing road and repair and replacement of one bridge, removal of one bridge; regrading the trailhead parking lot at Ballardini Ranch Trailhead; re-grading the horse arena at Bartley Ranch Regional Park; repair the access road and asphalt pathway at Betsy Caughlin Donnelley Park; re-grading the parking lot at Browns Creek Trailhead, Galena Creek Trailhead and Lockwood Trailhead; regrading the parking lot and ditch clean out at Golden Valley park; removal and replacement of a culvert at Michael D. Thompson Trailhead; re-grading the pasture access road at Rancho San Rafael Regional Park and restoring the entrance road at Silver Knolls Park.

Sealed bids for the Washoe County Parks Flood Damage Repair Project were opened on March 5, 2018. The list of bids received for the project is as follows:

Staff has verified in the System for Award Management Exclusions that no bidder is excluded from receiving federal government contracts as a result of being debarred; thus, none of the bidders is prohibited by NRS 338.017(2) from being awarded a public works contract.

### **PREVIOUS ACTION**

On June 27, 2017, the Board of County Commissioners (Board) approved the commitment of proceeds received from the sale of water rights in Fiscal Year 2016-17 totaling \$2,895,600 in the Capital Improvements Fund to be used for costs associated with the January and February 2017 flooding events.

On April 24, 2018, the Board is being asked to approve a resolution to augment the Capital Improvements Fund in the amount of \$484,017 to increase expenditure authority for capital projects from the January and February 2017 flood events for fiscal year 2017-18.

### **BACKGROUND**

Washoe County experienced two federally declared disasters in January and February of 2017. Both disasters were floods and many of Washoe County's parks, trails, and facilities were affected. Staff began a rapid assessment of damage immediately after the floods to determine if there was enough damage to be declared a federal disaster. Once the federal disasters were declared (January was 4303 and February was 4307), Washoe County officials began working with the Federal Emergency Management Agency (FEMA). FEMA representatives were assigned to specific project areas. Once assigned, Washoe County staff provided tours for FEMA representatives of the damaged areas to further assess and create project work orders for the specific areas. Once a project work order is assigned, Washoe County has the ability to receive 75% reimbursement from FEMA for the total cost of repairs.

FEMA has a standardized form, and each damaged area must apply to a specific category: A. debris removal, B. emergency protective measures, C. roads and bridges, D. water control facility, E. buildings and equipment, F. utilities, and G. parks, recreational facilities, other. There were two projects that were under the building and equipment category during the January flood (WASHE03 and WASHE13), and three parks/trails related projects (WASHG10, WASHG11, WASHG12). There was one park project from the February flood (4307) that was WASHG57.

Washoe County has 18 months from the time the disaster was declared to completion. For the January flood (4303), all work must be completed by August 17, 2018. For the February flood (4307), all work must be completed by September 27, 2018. Depending on the circumstances, Washoe County can apply for extensions on the completion date.

### **FISCAL IMPACT**

Funding for this project is available from the \$2,895,600 in proceeds from the water rights sale in FY 16-17 that was committed by the Board of County Commissioners for the costs associated with the January and February 2017 flooding events. This project is contingent upon the Board of County Commissioners approving an augmentation to the Capital Improvement Fund (402) utilizing sources from undesignated fund balance and

increasing expenditure appropriation in the amount of \$166,286 for FL011702.841 – WASHG10-Parks Flood Damage Repair on April 24, 2018.

Upon completion of the work, the County will apply for reimbursement from FEMA, which will reimburse up to 75% of the project costs.

**RECOMMENDATION**

It is recommended that the Board of County Commissioners award a bid and approve the Agreement to the lowest responsive, responsible bidder for the Washoe County Parks Flood Damage Repair Project [staff recommends Impact Construction, in the amount of \$166,286].

**POSSIBLE MOTION**

Should the Board agree with staff's recommendation, a possible motion would be. "Move to award a bid and approve the Agreement to the lowest responsive, responsible bidder for the Washoe County Parks Flood Damage Repair Project [staff recommends Impact Construction, in the amount of \$166,286]."
