SUBJECT: Recommendation to approve amendments totaling an increase of

[\$75,612.04] in both revenue and expense (no match required) for the FY18/19 Medical Marijuana Grant IO #11465; and direct the Comptroller's Office to make necessary budget amendments. (All Commission Districts)

SUMMARY

The Human Services Agency is requesting the Washoe Board of County Commissioners approve amendments to the adopted fiscal year budget and direct the Comptroller's Office to make the appropriate budget adjustments.

Strategic Objective supported by this item: Safe, secure and healthy communities

PREVIOUS ACTION

On January 9, 2018 the Board accepted the sub-grant from the State of Nevada Department of Health and Human Services, Division of Public and Behavioral Health Wellness and Prevention in the amount of [\$161,267; no county match] retroactively from July 1, 2017 through June 30, 2019.

BACKGROUND

The Subgrant was awarded for a total of \$161,267.00 for the period of July 1, 2017 through June 30, 2019 in an amount not to exceed \$91,267.00 for FY18 and an amount not to exceed \$70,000.00 for FY19. Grant IO 11465 did not include any budget authority at the time the FY19 budget was adopted. Additionally, the State of Nevada Department of Health and Human Services, Division of Public and Behavioral Health Wellness and Prevention approved our request to carry forward \$5,612.04 in unspent funds from FY18 into FY19.

The Washoe Board of County Commissioners approved the Subgrant Award for the Medical Marijuana grant at their January 9, 2018 meeting. A budget amendment in the amount of \$75,612.04 is needed to align the FY19 budget with the remaining balance of the award. The Human Services Agency FY19 adopted budget will need to be increased in the following accounts:
