SUMMARY

The Washoe Board of County Commissioners must approve amendments to the adopted fiscal year budget and direct Finance to make the appropriate budget amendments.

This funding is eligible to continue supporting a variety of positions, including but not limited to Informatics Specialist, Health Educator Coordinator, Health Educator II, Statistician, Epidemiologist, Public Health Investigator, Epidemiology Program Manager, Sr. Public Health Nurse, Intermittent Hourly Registered Nurse, for 24 months.

Washoe County Strategic Objective supported by this item: Fiscal Sustainability

PREVIOUS ACTION

On June 26, 2025, the District Board of Health reviewed the State Public Health Priorities and authorized the Chair to execute the Interlocal upon receipt. On August 7, 2025, the Interlocal was approved by the Board of Examiners.

BACKGROUND

Then Nevada State budget included \$1,182,080.00 in noncategorical funding for Northern Nevada Public Health for both State Fiscal Year 2026 and 2027, for a total of \$2,364,160.00.

This Interlocal provides ongoing support for the enhancement of public health services through the allocation of State Public Health Funds. This agreement establishes a framework for the enhancement initiatives, supporting improvements in public health programs and infrastructure, in alignment with the FY26-27 Governor's Executive Budget.

The Subaward provides funding for personnel, professional services, equipment non capital, computers non capital, capital equipment and indirect expenses.
