SUMMARY

Northern Nevada Public Health received a Notice of Subaward from the Board of Regents, NSHE obo University of Nevada Reno on November 14, 2025 to support the Supplemental Nutrition Assistance Education Program (SNAP-Ed). The funding period is effective from October 1, 2025 through September 30, 2026. A copy of the Notice of Subaward is attached.

PREVIOUS ACTION

BACKGROUND

The Supplemental Nutrition Assistance Program – Education (SNAP-Ed) is a federally funded grant program that supports evidence-based nutrition education and obesity prevention interventions and projects for persons eligible for the Supplemental Nutrition Assistance Program (SNAP). SNAP-Ed is delivered through a combination of educational strategies such as direct education and accompanied by policy, systems and environmental interventions to make healthy choices the easy choice and increase the consumption of healthy food and increase opportunities for physical activity. The subaward supports the school-based program, Power Up Kids – which is delivered at select Title I classrooms in the community to encourage healthy eating and movement among youth; it is implemented by the Chronic Disease and Injury Prevention Program.

The Subaward provides funding for personnel, travel, operating and indirect expenditures.
