SUMMARY

BACKGROUND

The Barracuda Open Championship Golf Tournament is an event being hosted at the Montreux Golf and Country Club. The event is organized and operated under the guidance of the Professional Golf Association and the Barracuda Open Foundation. The tournament will begin July 22 and continue through July 28, 2019.

FISCAL IMPACT

All personnel and equipment will be paid for by the Barracuda Open. It is estimated that security costs will be \$64,000.00. Reimbursement received will be deposited to 150200-485129 (Office of the Sheriff/Salary Reimbursement).
