#### **PREVIOUS ACTION**

On August 19, 2025, the Board of County Commissioners directed a [\$10,000.00] grant to Jewish Nevada – a nonprofit organization created for charitable, religious, or educational purposes – to support their mission to engage the community to invest, enrich, and ensure the vibrancy and continuity of Jewish life in Nevada through the Jewish cultural festival Milk and Honey; and a [\$10,000.00] grant to Lifestyle Homes Foundation - a nonprofit organization created for charitable, religious, or educational purposes – for the purpose of supporting food and clothing for seniors at the Cold Springs Family Center; and a [\$10,000.00] grant to Reno Toy Run - a nonprofit organization created for charitable, religious, or educational purposes – to support their mission of providing toys for children at Christmas; and a [\$10,000.00] grant to Senior ResQ - a nonprofit organization created for charitable, religious, or educational purposes – to support basic home finance classes for residents over age 62; and a [\$5,000.00] grant to Opportunity Alliance Nevada - a nonprofit organization created for charitable, religious, or educational purposes – to support the mission of building sustainable communities across Nevada to stabilize and improve the lives of individuals and families

#### **BACKGROUND**

Modification of guidelines and adoption of resolution for County Commission District Special Funding on February 10, 2015, created Commission District Special Funds for each Commission District. On May 20, 2025, the Board of County Commissioners approved the 2025-2026 fiscal year budget with special district funds allocated per Commission District in the amount of \$100,000.00. The monies appropriated are to support needs for all Washoe County residents.

Funds appropriated through the Commission District Special Funds must provide substantial benefit to the inhabitants of the County. The recipient must be a nonprofit organization, created for religious, charitable, or educational purposes, or a government entity. Funds shall not provide any personal or private benefit for the Commissioners, directly or indirectly benefit any campaign efforts by a commissioner, violate Ethics in Government law, or be used to purchase tickets to special events.
