

RESOLUTION  
TO AUGMENT THE 2018-2019 BUDGET OF THE WASHOE COUNTY HEALTH FUND

WHEREAS, total resources of the Washoe County Health Fund has sufficient available resources consisting of an opening fund balance of \$6,336,402 on July 1, 2018 and unbudgeted resources of \$108,426.11 from the closing of an Environmental Health Hazardous Materials program checking account; and

WHEREAS, the Washoe County Health Fund has the need for appropriation authority for unbudgeted expenditures; and

WHEREAS, the Washoe County Health Fund also has sufficient cash to meet these additional expenditures;

NOW THEREFORE BE IT RESOLVED, by the Board of County Commissioners of the County of Washoe, State of Nevada:

Section 1a. That Washoe County shall augment the Health Fund Fiscal Year 2019 budget by appropriating \$674,884.00, thereby increasing its appropriations as follows:
