# **SUMMARY**

Recommendation to approve the selection of Bob Murray & Associates to perform a nationwide search for the selection of a new Truckee Meadows Fire Protection District Fire Chief at a cost of \$22,000 plus reimbursable expenses at an approximate additional cost of \$8,000-\$12,000.

# **PREVIOUS ACTION**

On September 27, 2011, the Board of Fire Commissioners approved the recruitment and selection process for the Truckee Meadows Fire Protection District Fire Chief.

# **BACKGROUND**

The Fire Chief, Julie Paholke, HR Manager for Compensation and Recruitment—Washoe County, and the district Chair participated in interviews with three firms that responded to the district's inquiry. We discussed the process, timelines, and issues for the district. We also inquired about previous recruitments for similar positions and familiarity with government processes.

After the interviews, the consensus was unanimous for Bob Murray & Associates.

The timeline for filling the position is August to September 2025, and that timeline is adequate to complete a comprehensive process.

#### FISCAL IMPACT

The total cost including reimbursable expenses are anticipated to remain under \$40,000. The District will contingency funds to amend the General Fund FY24/25 budget. The resolution to amend the general fund will be included in the December budget augmentation.

# **RECOMMENDATION**

Staff recommend that the Board approve the selection of Bob Murray & Associates to perform a nationwide search for a new Truckee Meadows Fire Protection District Fire Chief at a cost of \$22,000 plus reimbursable expenses at an approximate additional cost of \$8,000-\$12,000 and authorize the current Fire Chief to execute all necessary agreements and documentation for the recruitment.
