Washoe County Strategic Objective supported by this item: Vulnerable Populations

#### PREVIOUS ACTION

On December 19, 2023 the Board approved item #8.J.1, the acceptance of FY24 subaward for senior nutrition program capacity building grant in the amount of \$170,000.00 retroactive from October 1, 2023 to June 30, 2024.

#### **BACKGROUND**

The Aging and Disability Services Division (ADSD) has awarded the Human Services Agency Senior Division a supplemental award to support the cost of nutrition equipment for the Congregate and Home-Delivered Meals programs to support the continued

operation of the senior nutrition program's Home Delivered Meals and Congregate meals. These programs help to allow seniors to age in place and provide a social environment for peer interaction.

To meet and maintain health requirements for the Congregate meal sites within the community, the Human Services Agency will need to upgrade and purchase new commercial kitchen equipment. This will ensure the equipment in use is built for the volume of use and capacity needed to support these satellite meal sites.

The Agency received the Notice of Subawards for these supplemental subgrant awards on January 7, 2025 and January 14, 2025 with an effective date of October 1, 2023, through June 30, 2025.

# **GRANT AWARD SUMMARY**

**Project/Program Name:** FY24 Nutrition Capacity Building

Scope of the Project: This grant supports the purchase of one (1) Natural gas 4-pan Steam table, four (4) Stainless Steel Commercial work tables, two (2) 80-gallon stationary stem kettle, one (1) 40-gallon tilt skillet, two (2) 10-pan full size combo oven natural gas, one (1) three door reach in refrigerator, and partial costs of four (4) heavy duty chrome wire shelving units for the Congregate and Home-Delivered Meals programs.

**Benefit to Washoe County Residents:** The equipment purchased will ensure food served to seniors as part of the nutrition program is transported and maintained at proper temperatures.

**On-Going Program Support:** The senior nutrition program is a long-standing program operated by Senior Services and supports Home Delivered Meals and Congregate services to Washoe County residents. As one of the largest programs operated by Senior Services, the nutrition program is supported by ongoing awards from ADSD and local, restricted senior budget.

**Award Amount:** \$146,314.00 (\$146,314.00 direct/\$0 indirect)

**Grant Period:** October 1, 2023 – June 30, 2025

**Funding Source:** (Governor's Office) American Rescue Plan Act of 2021,

US Treasury – Coronavirus State Fiscal Recovery Funds

**Pass Through Entity:** State of Nevada Aging and Disability Services Division
