- Emergency management coordinates emergency management agencies in partnership with the whole community to lessen the impact of disasters on people, property, the environment, and the economy.

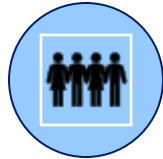

GOAL 1: Strengthen Homeland Security Program

- Coordinate with NNRIC & NTAC to implement the national infrastructure protection plan
- Promote security measures & facility resilience
- Create a culture of whole community preparedness centered on the theme of Make a Plan, Assemble a Kit, and Stay Informed



GOAL 2: Encourage mitigation strategies in developing resilience to natural & man-made disasters

- Engage in a cycle of validating and sustaining the Hazard Mitigation plan.
- Integrate prevention plan flood project efforts into regional flood response plans.
- Engage responsible stakeholders in project tracking for identified regional mitigation actions.
- Build the Mitigation Program to act as a facilitative leader in mitigation actions throughout the region.

GOAL 3: Create a coordinated approach to increasing a culture of preparedness for regional hazards throughout the region.

- Promote the Nevada Emergency Management Assistance Compact (NEMAC) and encourage mutual aid agreements to facilitate emergency response and recovery actions discrepancy.
- Promote Nevada Emergency Preparedness Association
- Collaborate with regional partners to identify preparedness goals and opportunities in the region.

GOAL 4: Coordinate the region's responding resources to natural & manmade disasters

- Develop, refine, & educate on information sharing tools such as WebEOC for the REOC, Emergency Operations Centers & Department Operations Centers (EOCs & DOCs), and the Northern Nevada Regional Intelligence Center (NNRIC).
- Be inclusive of all regional EM disciplines to allow all voices to be heard. EM, Emergency medical service, Fire service, Government administration, Hazardous materials, Health care, Law enforcement, Public communications, Public health, Public works, Volunteer Organizations, and Private Sector.

GOAL 5: Facilitate regional recovery actions related to natural & man-made disasters

- Coordinate the development of pre- and post- disaster recovery plans.
- Communicate and promote outreach to individuals, private and public sectors about pre- and post-recovery priorities.
- Identify possible ways to increase resiliency and minimize the impact on recovery.

GOAL 6: Meet annual EMAP reporting requirements

- Coordination activities to evaluate, maintain, and revise emergency management procedures in the region
- Implement corrective actions to maintain accreditation status.
