### **SUMMARY**

On June 30, 2019 terms to the Washoe County Advisory Board to Manage Wildlife for Steve Robinson, Arnie Pitts and Meghan DiRocco expire. Staff is still working to gather a list of applicants to present to the Board for appointment.

### **PREVIOUS ACTION**

October 9, 2018 the Board appointed Anthony DeMoe and Ray Kabisch for terms to expire on June 30, 2021.

August 23, 2016 the Board appointed Steve Robinson, Arnie Pitts and Meghan DiRocco for terms to expire on June 30, 2019.

June 23, 2015 the Board reappointed Michelle Spencer and Sean Shea with terms to expire on July 1, 2018.

June 17, 2014 the Board appointed William Tamblyn with a term to expire on June 30, 2016.

March 26, 2014 John Reed resigned from his position on the Washoe County Advisory Board to Manage Wildlife. The Board appointed Catherine Smith to fill that unexpired term to June 30, 2016.

July 1, 2014 the Board reappointed Rex Flowers' second term on the Washoe County Advisory Board to Manage Wildlife expired. The Board appointed William Gordon "Butch" Tamblyn with term to expire June 30, 2016.

August 27, 2013 the Board reappointed Mr. John Reed and appointed Mr. Miles Humphreys Jr. with terms to expire July 1, 2016.

June 26, 2012 the Board appointed Mr. Sean Shea and Ms. Michelle Spencer with terms to expire July 1, 2015.

May 24, 2011 the Board reappointed Mr. Rex Flowers with a term to expire July 1, 2014.

June 22, 2010 the Board reappointed Daryl Harwell to a second term to expire June 30, 2013 and appointed John Reed with a term to expire on June 30, 2013.

### **BACKGROUND**

Per NRS 50L.265 and 50I.270, individuals appointed must be citizens of Nevada and bona fide residents of the county from which appointed and be hunters, trappers or anglers or engaged in ranching or farming in the county. Members are appointed upon recommendation of the organized sportsmen and residents of Washoe County advising of the recruitment through the Washoe County website and related press release. In addition, the BCC shall appoint one qualified person to the board who represents the interests of the general public of the county.

### **FISCAL IMPACT**

There is no fiscal impact associated with the Board of Commissioners.

### **RECOMMENDATION**

It is recommended that the Board of County Commissioners extend the appointment of Steve Robinson, Arnie Pitts and Meghan DiRocco to the Washoe County Advisory Board to Manage Wildlife for an additional 3 months to expire October 1, 2019.
