PREVIOUS ACTION

On August 15, 2023, the Board of County Commissioners directed [\$1,000.00] to the Clean Tahoe Program-- a nonprofit organization created for religious, charitable or educational purposes – to aid the organization in improving the visual environment for Washoe County portions of Incline Village and Crystal Bay through proper litter and trash management and public education.

On July 18, 2023, the Board of County Commissioners directed [\$10,000.00] to the Clean Tahoe Program-- a nonprofit organization created for religious, charitable or educational purposes – to aid the organization in improving the visual environment for Washoe County portions of Incline Village and Crystal Bay through proper litter and trash management and public education.

On July 11, 2023, the Board of County Commissioners directed [\$25,000.00] to Truckee North Tahoe Transportation Management Association -- a government entity -- to support their efforts to integrate a North Lake Tahoe Airport Shuttle into the community; [\$10,000.00] to Edward C. Reed High School -- a government entity -- to support their upcoming turf replacement project; [\$5,500.00] to Truckee Meadows Tomorrow -- a nonprofit organization created for religious, charitable or educational purposes – with [\$3,000.00] to support their annual Community Progress Report, and [\$2,500.00] to support their Poverty, Homelessness and Housing Dashboard; [\$5,000.00] to the Indigenous Peoples Council on Biocolonialism -- a nonprofit organization created for religious, charitable or educational purposes -- to fund the purchase of supplies for their summer cleanup initiative; [\$5,000.00] to Sky Tavern -- a nonprofit organization created for religious, charitable or educational purposes -- to support their upcoming 2024 season of the Junior Ski Program; [\$5,000.00] to the Tahoe Fund -- a nonprofit organization created for religious, charitable or educational purposes -- to support Phase Two of their parking enforcement study; [\$1,800.00] to Jewish Nevada -- a nonprofit organization created for religious, charitable or educational purposes -- to support their upcoming Jewish Cultural Festival, Milk & Honey; [\$1,000.00] to the Albee Aryel Foundation -- a nonprofit organization created for religious, charitable or educational purposes -- to support their efforts to provide disadvantaged students with access to higher education; [\$1,000.00] to Latino Arte and Culture -- a nonprofit organization created for religious, charitable or educational purposes -- to retroactively support their bilingual play LGBTQIA+ Latinx performance at Reno Little Theater; [\$1,000.00] to Nevada Indoor Tennis and Pickleball -- a nonprofit organization created for religious, charitable or educational purposes – to support their mission to promote strong year-round programs and physical activity for youth and adult players.

BACKGROUND

Modification of guidelines and adoption of resolution for County Commission District Special Funding on February 10, 2015, created Commission District Special Funds for each Commission District. On May 16, 2023, the Board of County Commissioners approved the 2023-2024 fiscal year budget with special district funds allocated per Commission District in the amount of \$100,000.00. The monies appropriated are to support needs for all Washoe County residents.

Funds appropriated through the Commission District Special Funds must provide substantial benefit to the inhabitants of the County. The recipient must be a non-profit organization, created for religious, charitable, or educational purposes, or a government entity. Funds shall not provide any personal or private benefit for the Commissioners, directly or indirectly benefit any campaign efforts by a commissioner, violate Ethics in Government law, or be used to purchase tickets to special events.

Commissioner Hill has elected to support the following organization in fiscal year 2023-2024:

- [\$5,000.00] to Amplify Life -- a non-profit organization that is organized for charitable, religious, or educational purposes -- ensuring that people with disabilities live quality lives, filled with meaningful relationships, skills, and opportunities to learn, work, and grow. Providing all year-round programs including Prevocational, Social/Recreational, Camp Lotsafun, Life Skills: Physical Health, Friendship, and Dating Programs.
- [\$5,000.00] to the Tahoe Prosperity Center -- a non-profit organization that is organized for charitable, religious, or educational purposes -- to support the 2023 Envision Tahoe Venture Summit, which is an opportunity to catalyze change and take action to benefit our regional economy while supporting our community, quality of life, and environment. This year's focus is on organizing and accelerating Tahoe's innovation ecosystem, spearheaded by local entrepreneurs and success stories, where we plan to offer creative ideas, insight and inspiration.
- [\$1,000.00] to Reno Bike Project -- a non-profit organization that is organized for charitable, religious, or educational purposes -- to encourage daily cycling throughout Truckee Meadows by providing access to affordable recycled bikes, parts, public workspace, and bicycle maintenance classes.
- [\$1,000.00] to India Association of Northern Nevada -- a non-profit organization that is organized for charitable, religious, or educational purposes -- to support the promoting of Indian culture creating a positive, enjoyable and nurturing friendships and the Dandiya Hahotsav event.

FISCAL IMPACT

Sufficient FY23-24 budget authority exists within the Cost Center District 1 Constituents (C100101) and account Payments to other Agencies (710400). This action requests approval and distribution of a [total of \$12,000.00] to:
