RESOLUTION R24-81

AMENDING SHORT-TERM RENTAL (STR) APPLICATION FEES WITHIN THE WASHOE COUNTY DEVELOPMENT CODE MASTER FEE SCHEDULE, WITH AN EFFECTIVE DATE OF DECEMBER 1, 2024, AND AMENDING THE WASHOE COUNTY CODE CHAPTER 125 MASTER ADMINISTRATIVE ENFORCEMENT PENALTY AND FEE SCHEDULE, WITH AN EFFECTIVE DATE OF DECEMBER 1, 2024, AS AUTHORIZED BY WASHOE COUNTY CODE CHAPTERS 110 (DEVELOPMENT CODE) AND 125 (ENFORCEMENT; REMEDIES; PENALITIES) RESPECTIVELY. THESE AMENDMENTS WILL CONTINUE TO ALLOW FOR AN ANNUAL ADJUSTMENT TO SHORT TERM RENTAL FEES BASED ON THE WESTERN CONSUMER PRICE INDEX BEGINNING ON JULY 1, 2024.

WHEREAS,

- A. In March 2021, the Washoe County Board of County Commissioners (Board) approved amendments to Washoe County Code Chapters 50, 110 and 125 to establish standards and a permitting process for short-term rentals; and
- B. In March 2021, the Board also adopted new fees, fines and penalties associated with short-term rentals; and
- C. In August 2023, the Board amended the short-term rental application fees and approved an annual adjustment to those fees based on the Western Consumer Price Index beginning on July 1, 2024; and
- D. The Board desires to now establish reduced initial STR permit and renewal fees for properties listed as a primary residence (i.e., low cap status) by the Washoe County Assessor's Office, and desires to establish increased administrative penalties for the administration and enforcement of STR standards and permits.

NOW THEREFORE BE IT RESOLVED:

That the Board does hereby adopt the updated Development Code Master Fee Schedule as set forth in Attachment A-1 and the updated Master Administrative Enforcement Penalty and Fee Schedule as set forth in Attachment A-2, to become effective December 1, 2024.

NOTE 11: found within the Master Fee Schedule.

NOTE 12: Building and Fire District fees are based on a standardized rate. Final Fire District fees subject to adoption by each district's governing board and may vary.

NOTE 13: The Fire fee is charged for STR properties located in Extreme and/or High IWUI Fire Risk Ratings (per adopted Fire Code/Amendments and GIS mapping) only. This fee does not include repeated fire inspections. The need for Fire Inspections are determined by the applicable Fire District.

This appeal fee is for Tier 1 permits only. Appeals related to planning applications required by Tier 2 and Tier 3 STRs will pay the appeal fees applicable to all planning applications.

NOTE 14: Fees shall be reduced by \$100 for initial permits and \$50 for renewal permits for properties listed as low cap status per the Washoe County Assessor's Office.

- 1. There is no administrative penalty associated with a warning issued pursuant to WCC Section 125.160.
- 2. Pursuant to WCC Section 125.160(5), Washoe County will accept one-half of the administrative penalty amount as payment in full if received within 30 days, or in the case of a STR penalty within 14 days, of service of the administrative penalty notice.
- 3. Civil abatement penalty levied only in a non-judicial nuisance abatement case [authorized pursuant to NRS 244.3605(2)(d)].
- 4. Chronic nuisance civil penalty levied pursuant to a Court order in a chronic nuisance abatement case [authorized pursuant to NRS 244.3603(3)(a)].
- 5. A Stop Activity Order and penalty issued for operating a STR without the required permit may only be appealed to an Administrative Hearing and/or judicial review due to citations for such violations being issued under WCC Chapter 50 as a public nuisance. This fine amount is based on the cost of an STR permit plus a \$400 penalty.
