#### **PREVIOUS ACTION**

On May 20, 2025, the Board accepted monetary donations to the Human Services Agency Senior Services Fund used to support seniors in our community in the amount of [\$1,084.00], from multiple donors as described in this staff report, retroactive for the period January 1, 2025 through March 31, 2025.

On February 25, 2025, the Board: (1) accepted various items donated totaling an estimated market value of [\$500.50]; and (2) accepted donations from various donors to the Human Services Agency Senior Services Fund used to support seniors in our community in the amount of [\$10,577.10] retroactive for the period October 1, 2024 through December 31, 2024.

# **BACKGROUND**

Human Services Agency (HSA) regularly accepts donations from community members and business to be used to support seniors in our community. Acceptance of such donations requires Board approval.

Washoe County Code 15.140(1)(d) reads: 1. The Board of County Commissioners: (d) has sole authority to receive donations of personal property where the personal property has a value, singly or in the aggregate, of \$5,000.00 or greater from a contributor during a fiscal year.

Washoe County Code 15.140(1)(e) reads: 1. The Board of County Commissioners: (e) Must be notified when an officer or employee of a county department or agency accepts non-federal personal property for the use and benefit of the County where the personal property has a value, singly or in the aggregate, of less than \$5,000 from a contributor during a fiscal year. In such event, the officer or employee must notify the Board of County Commissioners in writing of the acceptance.

Washoe County Code 15.160(3) reads: An officer or employee of a county department or agency shall not accept, amend, or supplement a grant, and except as otherwise provided in section 15.140(1)(e), shall not accept, amend, or supplement a contribution of money or property without approval by the Board of County Commissioners.
