I forgot to send this last week and so of course I forgot about it. Below is the email from Washoe County requesting additional funding for the school zone grant. Let me know when you have time to discuss.

The breakdown of the funds is as follows.

The funds requested will be an additional \$5000.00

Approximately 62.5 hours total X approximately 80.00 hourly (OT)= \$5000.00

This breakdown will fund 2 Deputies 10 hours each per month until summer break (after the funds are approved by the (BCC)).

Matching funds 25%: approximately \$1250.00 Matching will come from Patrol and the traffic division.
