# **BACKGROUND**

The Board of Fire Commissioners approved the construction of new fire equipment bays and support spaces at TMFPD Fire Station #37, located at 3255 W Hidden Valley Drive. Mr. Savini is recommended because he has been intimately involved in this project from the beginning of the planning phases.

A construction manager brings specialized knowledge and experience to oversee complex building projects. Mr. Savini understands the technical and regulatory aspects of construction. He will ensure that the building is constructed according to the approved plans, help manage change orders, and assist with resolving any problems during construction. His expertise will minimize risk and help avoid costly mistakes.

Mr. Savini will oversee the project from start to finish, ensuring adherence to design specifications and high-quality standards. This will reduce the likelihood of rework or structural issues and keep the project on schedule.
