[\$129,204.00] in both revenue and expense to the FY20 Opioid Overdose Data to Action grant retroactive to February 1, 2020 through August 31, 2020 and if approved, direct the Comptroller's office to make the

#### **SUMMARY**

The Washoe Board of County Commissioners must approve amendments to the adopted fiscal year budget and direct the Comptroller's Office to make the appropriate budget amendments.

#### **PREVIOUS ACTION**

No previous action.

#### BACKGROUND

The State of Nevada recently received Opioid Overdose Data to Action funding from the Centers for Disease Control and Prevention in support of prevention activities related to the opioid overdose epidemic. States and local partners need access to complete and timely data to understand the scope of the epidemic in their community. This request is retroactive as the Health District received the Subaward on March 6, 2020.

The District Board of Health accepted this subaward at their March 26, 2020 meeting.

#### **GRANT AWARD SUMMARY**

**Project/Program Name:** Opioid Overdose data to Action Grant

**Scope of the Project:** Funding will support implementation of Good Grid, a community platform for requesting and delivering social services, with linkages to

OpenBeds, to measure and monitor treatment outcomes. It will also support a communitywide education campaign and staff travel.

**Benefit to Washoe County Residents:** Support linkages to care, increase data for decision-making by substance abuse prevention partners and educate the community.

**On-Going Program Support:** The program will continue to apply for funding to support the program.

**Award Amount:** \$142,124.00 (\$12,920.00 indirect)

**Grant Period:** February 1, 2020 through August 31, 2020 **Funding Source:** Centers for Disease Control and Prevention
