SUBJECT: Recommendation to approve a FFY19 Department of Homeland Security (DHS) grant passed through the State Homeland Security Program (SHSP) awarding [\$125,000.00 (no County match required)], for a Continuity of Operations and Continuity of Government project; authorize food purchases for Planning and Training events; retroactive from September 1, 2019 to August 31, 2021; If approved authorize the County Manager or his designee to sign the grant award documents when received; and direct the Comptroller's Office to make the necessary budget amendments. (All Commission Districts.)

SUMMARY

Washoe County Board of County Commissioners (BCC) is requested to accept a FFY19 Department of Homeland Security (DHS) grant passed through the State Homeland Security Program (SHSP) for a Continuity of Operations and Continuity of Government project awarding [\$125,000.00, no County match required]; authorize food purchases for Planning and Training events. Grant term is retroactive to September 1, 2019 through August 31, 2021.

The grant will provide funding for sustainment efforts in Northern and Southern Nevada regarding Continuity of Operations Plans (COOP).

The State issued this award retroactive from the date they received DHS funding.

PREVIOUS ACTION

December 17, 2013 – The Board of County Commissioners approved a 2012 Department of Homeland Security (DHS) State Homeland Security Program (SHSP) grant passed through the State of Nevada, Division of Emergency Management for \$119,960.00.

October 28, 2014 - The Board of County Commissioners approved a 2014 Department of Homeland Security (DHS) State Homeland Security Program (SHSP) grant passed through the State of Nevada, Division of Emergency Management for \$75,000.00.

December 12, 2017 – The Board of County Commissioners approved a 2017 Department of Homeland Security (DHS) State Homeland Security Program (SHSP) grant passed through the State of Nevada, Division of Emergency Management for \$115,000.00

November 13, 2018 – The Board of County Commissioners approved a 2018 Department of Homeland Security (DHS) State Homeland Security Program (SHSP) grant passed through the State of Nevada, Division of Emergency Management for \$150,000.00

The Board has approved this grant for the past 9 years.

BACKGROUND

This FFY19 Department of Homeland Security (DHS) State Homeland Security Program (SHSP) grant is an enhancement of the continuity of operations/continuity of government (COOP/COG) initiative begun in FFY 11.

These plans are directed by Homeland Security Presidential Directive (HSPD)-20 and Nevada Revised Statute (NRS) 239c. These plans are also a Government Accounting Office (GAO) best practice, and a component of the Emergency Management Accreditation Program (EMAP) as well as the National Fire Protection Association (NFPA) - 1600.

The COOP/COG project supports the Nevada Commission on Homeland Security priorities and goals. These plans are directly aligned with the goals of critical infrastructure protection, communications, and public safety. The COOP/COG project is a key component of the National Incident Management System (NIMS) compliance.

This project is an extension of the actions to build and sustain local government preparedness. Project deliverables include sustainment of existing plans, training, and workshops in the interest of providing for safe, secure, and healthy communities. The grant term is retroactive due to delays in process the grant award at the State of Nevada, Division of Emergency Management (NV DEM). The grant award documents were received in via email on October 2, 2019.

GRANT AWARD SUMMARY

Project/Program Name: 2019 SHSP Continuity of Operations

Scope of the Project: The benefit of this funding is to sustain and provide planning and training to agencies to continue their essential functions and mitigate disruptions to operations across a broad spectrum of hazards and emergencies.

Benefit to Washoe County Residents: The benefit of this funding is for emergency preparedness for the protection of life and property in the region from hazards and disasters.

On-Going Program Support: If additional program support is needed past the enhancement phase, we will continue to seek grant funding.
