**SUBJECT:** Recommendation to the Board of County Commissioners to acknowledge a

supplemental grant of \$1,790.90 which increases the original award to \$29,215.90 [no County match required], awarded to the Second Judicial District Court from the Supreme Court of Nevada, Administrative Office of the Courts for building a perimeter fence on the north side of the 75 Court Street building and creating a safe outdoor area for employee use; and direct Finance to make the necessary budget amendments. #### **SUMMARY**

This project will increase court security and public safety by building a perimeter fence on the north side of the Second Judicial District Court (SJDC), 75 Court Street building, encompassing the building's generator, cutting off public access to a non-public stairwell to the basement, and reducing access to a forthcoming new HVAC unit to provide air circulation to basement areas. With the fencing, a safe outdoor area for employee use will also be created

#### **PREVIOUS ACTION**

Original award of \$27,425 received consent at the August 27, 2024, meeting.

#### **BACKGROUND**

The Second Judicial District Court, general jurisdiction building, is located on a lot in downtown Reno at 75 Court Street, Reno, Nevada. Over the past several years, the District Court has had multiple security threats occur on the lawn area including but not limited to someone living in the basement stairwell, individual(s) breaking windows in the historical section of the courthouse, and individual(s) tampering with the inground

irrigation system resulting in damage to the building and case files stored in the basement. These incidents increased between 2020 and 2021 when the economic impacts of the COVID-19 epidemic resulted in an increase in the unsheltered population living in downtown Reno.

Despite security measures being taken to reduce access to the stairwell, members of the public continue to try to access the stairwell. The generator is enclosed, but accessible by the public, and someone could access it and do harm to the public, the courthouse, or its backup systems. Additionally, COVID-19 epidemic brought to the forefront the need for enhanced airflow in employee workplaces. Washoe County Facilities will be installing a new HVAC unit to service the basement area, providing much needed airflow for employee safety and welfare. The installation of this HVAC unit will result an additional entry point that could potentially be exploited by wrong-doers.

Additionally, providing a fenced area will also provide the SJDC an opportunity to have a safe outdoor space available for employee use. The SJDC has limited and small employee breakrooms, none of which are adequate to provide enough space for the SJDC's 190 employees.
