 - **SUBJECT:** Recommendation to approve a Security Agreement between the Reno Rodeo Association and the County of Washoe on behalf of Washoe County Sheriff's Office to provide uniformed Deputy Sheriffs for security [No fiscal impact to County, estimated \$138,000 Annual Security Costs Reimbursed] during Reno Rodeo events occurring for the period of June 15, 2025, through the last day of the Reno Rodeo 2027 performance. (All Commission Districts.)

SUMMARY

The Reno Rodeo Association has requested that the Washoe County Sheriff's Office provide uniformed Deputy Sheriffs to aid with security during the Reno Rodeo. The agreement provides for reimbursement to the County for the cost of providing the uniformed Deputy Sheriffs during the 2025-2027 Reno Rodeos.

BACKGROUND

The Reno Rodeo is an annual event, which begins around the third week in June and continues for one week at the Livestock Events Center and Fairgrounds. The Washoe County Sheriff's Office has provided uniformed deputy sheriffs for security during the Reno Rodeo for numerous years with the prior three-year contract expiring in 2024. Deputy Sheriff presence is requested to help ensure a calm and safe event.

FISCAL IMPACT

There will be no fiscal impact to the County. All costs related to personnel and equipment will be reimbursed through this security agreement. The reimbursement and all associated FY25 expenditures estimated at \$138,000 will be posted to Internal Order 60009 (Sheriff OT Reno Rodeo):

RECOMMENDATION

It is recommended that the Board of County Commissioners approve the Security Agreement between the Reno Rodeo Association and the County of Washoe on behalf of Washoe County Sheriff's Office to provide uniformed Deputy Sheriffs for security [No fiscal impact to County, estimated \$138,000 Annual Security Costs Reimbursed] during Reno Rodeo events occurring for the period of June 15, 2025, through the last day of the Reno Rodeo 2027 performance.
