SUBJECT: Recommendation to accept the Fund for a Resilient Nevada Project Period 2 subgrant award from the State of Nevada Department of Health and Human Services (DHHS), in the amount of [\$480,258.00; no county match] to provide Peer Recovery Support Specialist (PRSS) services and timely substance abuse disorder evaluations and treatment as elements part of the Sobriety Treatment and Recovery Teams (START) evidence-based program, retroactive for the period of July 1, 2025 through June 30, 2027; authorize the Director of Human Services Agency to execute the sub-grant documents; and direct Finance to make the necessary budget amendments. SUMMARY

The Washoe County Human Services Agency recommends acceptance of the Fund for a Resilient Nevada Project Period 2 subgrant award from the State of Nevada Department of Health and Human Services (DHHS), in the amount of [\$480,258.00; no county match] to provide Peer Recovery Support Specialist (PRSS) services and timely substance abuse disorder evaluations and treatment as elements part of the Sobriety Treatment and Recovery Teams (START) evidence-based program, retroactive for the period of July 1, 2025 through June 30, 2027; authorize the Director of Human Services Agency to execute the sub-grant documents; and direct Finance to make the necessary budget amendments.

PREVIOUS ACTION

On June 24, 2025, the Board of County Commissioners approved item # 6.G.4, accepting the FY25 Fund for a Resilient Nevada subgrant award (project period #1) from the State of Nevada Department of Health and Human Services (DHHS) in the amount of [\$69,066.00; no county match] retroactive for the period of January 1, 2025 to June 30, 2025.

BACKGROUND

Washoe County Human Services Agency has been supporting behavioral health services for clients with substance use issues since FY03 by providing services to parents with children who have been placed in the child welfare system by the Agency due to child abuse and/or neglect related to substance abuse.

This grant funding supports Peer Recovery Support Specialists (PRSS) and timely substance abuse evaluations and treatment through implementation of the Sobriety Treatment and Recovery Teams (START) evidence-based model program. START assists and empowers parents of children ages 0 to 5 struggling with substance use disorders (SUD) by identifying main concerns, developing collaborative care plans that include measurable goals and objectives, and by providing clients with peer support from individuals with lived experiences. The PRSS is a mentor, companion, resource broker, community tour guide, educator, and advocate for clients. The PRSS guides clients toward long-term behavioral change through intensive mentorship and support through the stages of change with sobriety. START requires SUD evaluations and treatment initiated within a short timeframe. Contractors identified in the NOSA have been vetted and have the capacity to meet this timeframe.

The Agency will collect and report on the data required for the subaward. Data collection will include family demographics, date of referral to START program, substance use evaluations, treatment, PRSS case management details, selection of appropriate interventions, community referrals, and family successes.

The funding includes 5% for administrative expenses calculated into the total subaward amount, pursuant to NRS 433.712 through 433.744. Administrative expenses include but are not limited to implementation or operation of opioid recovery programs. The 5% administrative expenses are labeled as Indirect Costs on the NOSA despite grant funding not allowable for indirect costs, nor County allowable due to no personnel funded through the project. The administrative expenses will be applied to operating expenses.

The Notice of Subaward for this grant was received by the Human Services Agency on September 2, 2025; therefore, retroactive approval is requested.

GRANT AWARD SUMMARY

Project/Program Name: Fund for a Resilient Nevada, Sobriety Treatment and Recovery Teams (START) Substance Use Treatment & Recovery Services

Scope of the Project: To provide Peer Recovery Support Specialist services and timely SUD evaluations and treatment for clients with opioid use/misuse/disorder issues.

Benefit to Washoe County Residents: Support for clean and sober parenting

On-Going Program Support: Project Period 2 is for the period of July 1, 2025 to June 30, 2027, funding received and approved through a continuing application and budget process. If future funding is reduced or discontinued, HSA will seek other funding sources to support services or reduce or eliminate services.

Award Amount: \$480,258.00 direct/\$0.00 indirect

Grant Period: July 1, 2025 to June 30, 2027

FISCAL IMPACT

Should the board accept this grant award and approve these amendments, the FY26 Human Services Agency, Children Services Fund (228) adopted budget will be increased by \$480,258.00 in both revenues and expenditures in the following accounts:
