BACKGROUND

The University of Nevada, Reno School of Medicine (UNRMED) is providing funds to Washoe County, through the Cares Campus, to support street medicine services to individuals experiencing homelessness. These funds are a subaward from the Health Resources and Services Administration (HRSA) to UNRMED to support larger street medicine efforts in the region.

AGENDA ITEM # _____

Street medicine is defined as supervised, community-based clinical training activities delivered in non-traditional care settings and clinical environments servicing individuals experiencing homelessness. More specifically for this project, these funds will be used to purchase supplies and materials in support of street medicine (i.e. wound care training supplies, infection prevention materials, educational tools, etc.), and training and educational support for Cares Campus staff.

The Agency received the Contract for this award on April 3, 2026, with an effective date of March 1, 2026; therefore, the request to accept this award is retroactive.

Scope of the Project: To support community-based training environments through the Cares Campus for residents providing care to individuals experiencing homelessness
