SUMMARY

The Second Judicial District Court accepted various gift donations at an estimated value of \$8,279.46 from the Reno Rodeo Foundation in support of the Reading Room Project during July 1, 2024, to June 30, 2025.

The Second Judicial District Court accepted various gift donations at an estimated value of \$250.00 from anonymous donors to provide stuffed animals to children who come to court during July 1, 2024, to June 30, 2025.

PREVIOUS ACTION

On August 27, 2024, the Board approved item #7C2, donations at an estimated value of \$11,619.29 from the Reno Rodeo Foundation to the Second Judicial District Court.

On July 19, 2022, the Board approved item #6A1, donations at an estimated value of \$2,474.43 from the Reno Rodeo Foundation to the Second Judicial District Court.

On April 26, 2022, the Board approved item #7.D.1, donations at an estimated value of \$2,820.00 from the Reno Rodeo Foundation and Tru Vista to the Second Judicial District Court.

On December 18, 2018, the Board approved item #7.A, donated murals valued at \$3,000.00 from artist Kandyce Ray to the Second Judicial District Court.

BACKGROUND

The Second Judicial District Court developed the Reading Room project with the intent of providing a friendlier and warmer space for children and families attending court and to provide a book, toy, and/or teddy bear to each child who comes to court. The Reno Rodeo Foundation provides ongoing donations of books, toys, and teddy bears to ensure each child who comes to court can leave with an item.

Additional donors provided teddy bears and/or other stuffed animals for children who come to court.
