SUMMARY

PREVIOUS ACTION

April 17, 2018, The Board of Fire Commissioners approved the purchase of two (2) new type I structure engine from Superior Equipment, 7285 South 700 West, Midvale, Utah in an amount of \$1,244,228.84 using the NPPRGov Fire Rescue GPO program as allowed by NRS 332.195.

BACKGROUND

Currently TMFPD has two new type I structure engines under construction by Pierce Manufacturing (Superior Equipment). Once the engines builds are complete, they will require certain supplies and equipment, including, but not limited to, fire hose, nozzles, tools, self-contained breathing apparatus and extrication equipment to be fully functional. LN Curtis is the vendor the District has used to supply loose equipment of this type.

FISCAL IMPACT

This purchase is exempt from competitive bidding per NRS 332.115.1(m): Supplies, materials or equipment that are available pursuant to an agreement with a vendor that has entered into an agreement with the GSA or other governmental agency.

The approved FY18/19 capital budget includes sufficient funding for the purchase of equipment and supplies necessary to fully equip the two new type I engines approved for purchase in FY17/18.

RECOMMENDATION

Staff recommends approval of the purchase of supplies and equipment for two new type I structure engines from LN Curtis & Sons in an amount not to exceed \$160,000 using the FR-GPO Contract #0000170 or similar contract as allowed by NRS 332.115.1.
