

AMENDMENT to CASEWORTHY SAAS SERVICES AGREEMENT

for Services Change Order

This Amendment (the "Amendment") dated effective as of the date signed by both parties below (the "Effective Date"), is between CaseWorthy, Inc. ("CaseWorthy"), and Washoe County ("Customer"). This Amendment amends the terms of the SaaS Services Agreement (the "Agreement") between the parties, dated July 23, 2023. All capitalized terms used and not otherwise defined herein shall have the meanings given to such terms in the Agreement.

The parties have discussed and agreed to certain changes to CaseWorthy's Services, as set forth in the Agreement, including Schedule A (the Order Form and SOW) that is part of the Agreement. The parties hereby agree to amend the Agreement by adopting the changes and terms set forth in the Change Order form attached to this Amendment as Attachment 1 (the "Change Order"). CaseWorthy agrees to provide the Services and work described in the Change Order for the fees and costs specified therein, and Customer agrees to pay for such Services.

Except as amended hereby, all terms and conditions of the Agreement shall remain in full force and effect. All Services performed and software and other work or deliverables provided by CaseWorthy are subject to the terms of the Agreement, except as otherwise specifically set forth in the attached Change Order.

Washoe County has agreed to proceed with the addition of CORE functionality. A formal Statement of Work (SOW) was prepared and submitted for Washoe County's review and approval. That Statement of Work was executed on August 12, 2025. The fees associated with that are:
CaseWorthy CORE - \$12,720 (Annual Fee)
CaseWorthy CORE Data Engineer - \$2,750 (Annual Fee)
CORE Activation - \$3,000 (One-time Fee)
CORE Training - \$1,800 (One-time Fee)
As part of the CORE SOW negotiations, CaseWorthy agreed to remove the Year 3 fees associated with the Web Portal and Power BI Embedded from the original contract. The total of this credit is \$10,275 (\$5,408 for Web Portal and \$4,867 for Power BI Embedded) and it will remain on your account to be used on a future invoice.
