### SUMMARY

The Reno Rodeo Association has requested that the Washoe County Sheriff's Office provide uniformed Deputy Sheriffs to aid with security during the Reno Rodeo. The agreement provides for reimbursement to the County for the cost of providing the uniformed Deputy Sheriffs during the 2019-2021 Reno Rodeos.

### PREVIOUS ACTION

On April 16, 1996, the Board approved a Security Agreement for the 1996 Reno Rodeo.

On April 13, 1999, the Board approved a Security Agreement for the 1999 Reno Rodeo.

On June 27, 2000, the Board approved a Security Agreement for the 2000 Reno Rodeo.

On June 18, 2002, the Board approved a Security Agreement for the 2002-2007 Reno Rodeos.

On May 27, 2008, the Board approved a Security Agreement for the 2008-2012 Reno Rodeos.

On May 28, 2013, the Board approved a Security Agreement for the 2013-2015 Reno Rodeos.

### **BACKGROUND**

The Reno Rodeo is an annual event, which begins around the third week in June and continues for one week at the Livestock Events Center and Fairgrounds. The Washoe County Sheriff's Office has provided uniformed deputy sheriffs for security during the Reno Rodeo for numerous years with the prior three-year contract expiring in 2018. Deputy Sheriff presence is requested to help ensure a calm and safe event.

### **FISCAL IMPACT**

There will be no fiscal impact to the County. All costs related to personnel and equipment will be reimbursed through this security agreement. Reimbursement received will be deposited to account 150200-485129 (Office of the Sheriff-Salary Reimbursement).

### **RECOMMENDATION**

It is recommended that the Board of County Commissioners approve Security Agreement between the Reno Rodeo Association and the County of Washoe on behalf of Washoe County Sheriff's Office to provide uniformed Deputy Sheriffs for security [No fiscal impact to County, Estimated \$115,000 Annual Security Costs Reimbursed] during Reno Rodeo events occurring for the period of June 20, 2019 through the last day of the Reno Rodeo 2021 performance.
