SUMMARY

Washoe County provides grants to address special community needs. As with all grants provided by Washoe County these funds can only be provided to a private organization, not for profit, or to a governmental entity, for charitable or educational purposes, and must provide a substantial benefit to the inhabitants of the County. Grant award for FY 2017-2018 for the Glenn Duncan S.T.E.M. Academy.

BACKGROUND

Historically, Washoe County has made Community Support funds available to local community based providers to support services that address diverse health and human service needs in the community, or contribute to economic development and quality of life issues.

Washoe County began working with the Glenn Duncan S.T.E.M. Academy as a Partner in Education in early 2014. The purpose of Partners in Education is to engage business and community organizations to establish school partnerships and advocate for resources with a goal of at least one partner per school who provides volunteer time and expertise, financial or in-kind support, and/or allows students/classrooms to tour their location.

This grant for the Glenn Duncan S.T.E.M. Academy will support sponsorship opportunities for children in community activities i.e. Girls on the Run, class projects, funding for field trip transportation, physical education equipment, reading books, and educational games.
