SUBJECT: Recommendation to accept a Grant Agreement between Washoe County

Human Services Agency and The William N. Pennington Foundation in the amount of [\$325,000.00; no county match] retroactively for the period of July 29, 2025 to July 28, 2026 in support of children in foster care; retroactively authorize the Director of the Human Services Agency to execute the agreement; and direct Finance to make the necessary budget

SUMMARY

Recommendation to accept a Grant Agreement between Washoe County Human Services Agency and The William N. Pennington Foundation in the amount of [\$325,000.00; no county match] retroactively for the period of July 29, 2025 to July 28, 2026 in support of children in foster care; retroactively authorize the Director of the Human Services Agency to execute the agreement; and direct Finance to make the necessary budget amendments.

These funds will be used to provide clothing, school and activity supplies, diapers, hygiene items, educational toys, and Christmas gifts for approximately 630 children in Washoe County foster care system and to purchase items for the Family Engagement Center supply closet to be distributed to children entering foster care.

PREVIOUS ACTION

On October 8, 2024, the Board of County Commissioners accepted item #10, to accept a Grant Agreement between Washoe County Human Services Agency and The William N. Pennington Foundation in the amount of [\$315,000.00; no county match] retroactively from June 26, 2024 to June 25, 2025 in support of children in foster care.

On October 10, 2023, the Board of County Commissioners accepted item #7.C.1. to accept a Grant Agreement between Washoe County Human Services Agency and The

William N. Pennington Foundation in the amount of [\$270,000.00; no county match] retroactively from July 26, 2023 to July 25, 2024 in support of children in foster care.

On August 23, 2022, the Board of County Commissioners accepted item #17 to accept a Grant Agreement between Washoe County Human Services Agency and The William N. Pennington Foundation in the amount of [\$342,500.00; no county match] retroactively from June 28, 2022 to June 27, 2023 in support of children in foster care.

On July 20, 2021, the Board of County Commissioners accepted agenda item #16 to accept a Grant Agreement between Washoe County Human Services Agency and The William N. Pennington Foundation in the amount of [\$326,250.00; no county match] retroactively from June 30, 2021 to June 29, 2022 in support of children in foster care.

On March 31, 2020, the Board of County Commissioners accepted agenda item #8 to accept a Grant Agreement between Washoe County and The William N. Pennington Foundation in the amount of [\$371,250.00; no county match] retroactively from January 17, 2020 in support of children in foster care for calendar year 2020.

On March 31, 2020, the Board of County Commissioners accepted agenda item #9 to accept a Grant Agreement between Washoe County and the William N. Pennington Foundation in the amount of [\$198,600.00; no county match] retroactively from January 17, 2020 to support the installation of a playground on the Our Place Campus.

BACKGROUND

The William N. Pennington Foundation was founded in 1989 with a focus on supporting education, community services, health care, and medical research primarily in the State of Nevada, with an emphasis on Reno and Northern Nevada. The Foundation supports organizations that help people and families persevere through difficult times and is known for providing funding to support clothing and educational needs for disadvantaged citizens.

The Agency received the notice of award for this grant agreement on August 28, 2025 with an effective date of July 29, 2025, thus the request to retroactively accept this grant agreement.

GRANT AWARD SUMMARY

Project/Program Name: Pennington Foundation – Foster Children Support

Scope of the Project: Funding has been provided for approximately 630 foster children in Northern Nevada to be provided with support.

Benefit to Washoe County Residents: This funding will provide significant support to the foster children in HSA's care by assisting the Agency with supplying clothing, school supplies, diapers, hygiene items, educational toys and Christmas presents as needed by each child in the amount of about \$500 per child; and approximately \$10,000 shall be

allotted to fund the supply closet at the Family Engagement Center to assist children entering foster care.

On-Going Program Support: This grant will help HSA in supporting the needs of foster children and assist in proving normalcy activities to support their wellbeing and transition through foster care. These are costs that present regardless of this funding source and continue to be a year-to-year need addressed by HSA.

Award Amount: \$325,000.00 (\$325,000.00 direct; \$0 indirect)

Grant Period: July 29, 2025 to July 28, 2026
