SUBJECT: Recommendation to accept cash [\$14,999.00] and in-kind donations [estimated value \$80,200.00] from various businesses, organizations and individuals for Regional Parks and Open Space programs and facilities; and direct the Comptroller's Office to make the appropriate budget amendments. (All Commission Districts.)

SUMMARY

Accept a total of \$14,999.00 in cash and in-kind donations [estimated value \$80,200.00] from various businesses, organizations and individuals for Regional Parks and Open Space programs and facilities.

Washoe County Strategic Objective supported by this item: Stewardship of our Community.

PREVIOUS ACTION

Donations are frequently made to the Regional Parks and Open Space programs and facilities and formally accepted by the Board of County Commissioners (Board).

BACKGROUND

The citizens of Washoe County continue to support our parks, open space and natural resources through their generous donations of time, materials, services and cash. Cash [\$14,999] and in-kind donations [estimated value \$80,200.00] have been received for park maintenance, improvements, programming, and to assist with the safety and comfort of our citizens.

Cash donations received are dedicated to the Lazy 5 Park purchase and installation of bleachers for The Hive community recreation center in partnership with Keep Truckee Meadows Beautiful, the Bartley Ranch Huffaker Historic School pathway project, Bowers Mansion and Galena Campground programs, to support May museum marketing and programming, and for May Arboretum garden memorial benches, maintenance and improvements.

- AmeriCorps staff services for the May Arboretum [\$9,200],
- Three (3) winter seasonal staff services for the May Arboretum [\$34,000], and

FISCAL IMPACT

General cash donations for the various Regional Parks and Open Space facilities, programs and events have been deposited to IN20020, Parks Donations (\$3,114.00).

Wilbur D. May Museum cash donations (\$55.00) have been deposited to cost center 640200 and Wilbur D. May Arboretum cash donations (\$11,830.00) have been deposited to IN20034 (both in Other Restricted Fund 270-6).

Should the Board accept these donations, the FY19 adopted budget will need to be amended in the following accounts:

There is no above-base maintenance cost associated with any of these donations. The donations enable Regional Parks and Open Space to offer additional programming or assist in repairing, replacing or maintaining facilities and items that are not supported by appropriations elsewhere, and to support volunteer efforts with no impact to the general fund.

RECOMMENDATION

It is recommended that the Board of County Commissioners accept cash [\$14,999.00] and in-kind donations [estimated value \$80,200.00] from various businesses, organizations and individuals for Regional Parks and Open Space programs and facilities; and direct the Comptroller’s Office to make the appropriate budget amendments.
