**PREVIOUS ACTION**

On February 6, 2025, the Board of County Commissioners held a concurrent meeting regarding the collaborative regional emergency management process, including strategic goals, community lifelines, and updates on ongoing efforts related to emergency management preparedness and responsive plans.

**BACKGROUND**

This item seeks approval by the Board to accept donation from Greg Nelson 1993 Living Trust, Frankie Sue Del Papa, Trustee, in the amount of [\$21,101.60, no match] to provide Washoe County with funding for a Public Service Intern to assist the Emergency Management Administrator with issues surrounding wildfire prevention, evacuations, and any other needs of Washoe County and its residents and surrounding areas in the event of wildfires.

The Job Evaluation Committee has approved the creation of a new intermittent (part-time) 0.40 FTE Public Service Intern position, pay grade 012 on February 20, 2025. This item was accepted as reported: *Public Service Intern*, pay grade 012 (\$15.24 - \$20.33 per hour). The new intermittent position is 100% financed by the donation. The position will end when funding is exhausted.

**FISCAL IMPACT**

The intermittent (part-time) Public Service Intern position will cost approximately \$21,101.06 for a 12-month period. Should the board accept this donation and approve these amendments, the FY25 Office of the County Manager’s budget will be increased in both revenues and expenditures in the following accounts:
